Council tariffs are reviewed annually and then increased by a determined % in line with budget guidelines. These equitable and affordable increments contribute to the running of the City and ensure continuous service provision to all the residents of the City of Johannesburg. Understanding your tariffs helps you know what you pay for and how it is calculated. Your tariffs are a structure that is used to determine what different property categories customers will be charged, this is to help customer pay in line with their usage and lifestyle, as well as property categorisation.

Electricity tariff

The average increase of 7.17% is as applied to the National Regulator of South Africa (NERSA). All electricity consumed used to attract a Demand Side Management Levy of 2c/kWh. This levy has been discontinued. A new Network Surcharge of 6c/kWh is being introduced with effect from 1 July 2018. Residential consumption of 500kWh per month and below will be exempt from the surcharge, meaning all residential consumption above 500kWh per month will be subjected to this surcharge.

Refuse Charges

- This charge is levied to residential customers (domestic) determined based on the value of property.
- Tariffs generally increase by 6% for lowest property value and 8% for highest property value categories.
- Properties valued at and below R350 000, as well as indigent's households are exempt from this charge.

Water Tariffs

- Average tariff increase on water, sewerage and sanitation is 13.2%, based on the Rand Water tariff increase of 12.2% and includes a 1% retail margin aimed at improving and maintaining the distribution network.

- For domestic customers, a monthly water demand management levy of R22.84 per month will be charged

- For non-domestic customers, a monthly water demand management levy of R200.00 per month per stand will be charged. households are exempt from this charge.

Penalty Fees

- Fees payable in respect of the delivery of the "Pre" Termination notice R251,54 (Excl VAT)

- Final Notice to the consumer - The delivery fee of R148.32 (Excl VAT) per delivery will be levied on the consumers account.

No rates are levied on the first R350 000 of the property value.
